


# Dillard University

### ARTICULATION AGREEMENT

Since it is incumbent upon the institutions of higher learning in the States of Louisiana and Texas to provide educational opportunity in the most innovative and efficient manner possible, and

Since higher education budgets are limited and imaginative methods must be found to effect economics without affecting quality, and

Since Dillard University and St. Philip's College have as their major mission to empower our diverse communities for success.

Since geographic locations of these institutions argue for close cooperation between the two institutions, and

Since the full and active cooperation between Dillard University and St. Philip's College will underscore for the States of Louisiana and Texas the importance of university-community college interactions, therefore:

Dillard University and ACCD on behalf of St. Philip's College do hereby enter into this general articulation agreement.

Dillard University and St. Philip's College do hereby agree that:

1. A student has satisfactorily completed an Associate of Arts, Associate of Science or Associate of Applied Science degree at St. Philip's, then he/she:
  - a. Will receive full recognition of that degree toward the completion of the Bachelor of Arts or Bachelor of Science degree programs at Dillard University. Students who hold an associate degree will

have no General Education Core Curriculum requirements to meet.

b. Will be required to complete a minimum of 30 post-associate-degree semester hours at Dillard University for the Bachelor of Arts or Bachelor of Science degree. Dillard University online and in-class courses count toward this requirement.

c. Will be awarded the Bachelor of Arts or Bachelor of Science Degree from Dillard University upon successful completion of:

i. Requirements in the major course of study as stated in the University Catalog.

ii. Required total credit hours to complete the degree as stated in the Dillard University Catalog (a minimum of 120 semester hours for the Bachelor of Arts and Bachelor of Science degrees).

iii. All other graduation requirements, as stated in the University Catalog, including those pertaining to standards or progress, upper division hours, hours in residence, demonstration of specific competencies, and articulated core where relevant.


2. Programs at both institutions will be reviewed with an eye toward future articulation of other programs leading to associate degrees at St. Philip's College and baccalaureate degrees at Dillard University.

3. On a bi-annual basis a representative of Dillard University will visit the campus of St. Philip's College for the purpose of presenting programs offered at Dillard University and recruiting. This representative may be an alumnus already in the area.

4. Annually Academic Officials at each institution will meet and or conduct a phone conversation about the progress and satisfaction of this agreement.

- 5. Dillard University will guarantee placement as well as college credit for all students transferring to accepted articulated programs after having completed an associate degree and after having followed a specific articulated plan of study.
- 6. Each party to this agreement will highlight the Dillard-St. Phillip's College Articulation Agreement on its website and transfer agreement literature, and in addition will publish articulated plans of study that lead most efficiently to a Dillard University Bachelor of Arts or Bachelor of Science degree.
- 7. Each party to this agreement will communicate announcements of campus events to the other party.
