

**INTERINSTITUTIONAL AGREEMENT FOR
EDUCATIONAL AND SCIENTIFIC COOPERATION BETWEEN**

**the Board of Regents of the University of Wisconsin System
on behalf of the University of Wisconsin – Milwaukee**

and

Dillard University

In consideration of the promotion of educational cooperation and educational exchanges, this agreement has been executed at Milwaukee, Wisconsin, U.S.A. between the above parties on the dates shown below.

The University of Wisconsin-Milwaukee ("UWM") and Dillard University ("Dillard") join in the following Interinstitutional Agreement for educational and scientific cooperation.

UWM and Dillard will endeavor to cooperate in joint educational programs and research projects. To the extent feasible, both universities will encourage direct contact and cooperation between their faculty members, departments, and research institutes under provisions of this agreement.

Within fields that are mutually acceptable, as agreed by the parties in writing, the following general forms of cooperation may be pursued:

1. Exchange of information, including (but not limited to) exchange of library materials and research publications consistent with applicable copyright law;
2. Exchange of faculty members for purposes of research, lectures, and seminars/symposia;
3. Joint research activities; and
4. Exchange of graduate and undergraduate students for study and research.

Arrangements for specific visits, exchanges, and other forms of cooperation will be developed jointly and will be agreed upon, in writing, for each specific case. Any ongoing student exchanges will require a supplementary written agreement, specifying the terms and nature of the student exchange.

No monetary consideration will be exchanged under this agreement between the institutions who are parties hereto. Both parties understand that all financial arrangements for future projects will have to be negotiated and agreed upon by the parties, in writing, and will depend on the availability of funds for each party.

In exchange for Dillard's agreement to hold UWM, its officers, employees, and agents harmless for damage to persons or property resulting from the willful or negligent acts or omissions of Dillard's employees, agents, or officers, UWM agrees to hold harmless Dillard from any and all liability, including claims, demands, losses, costs, damages and expenses of every kind and

description (including death), or damages to persons or property arising out of, or in connection with, or occurring during the course of this Agreement, where such liability is founded upon and grows out of the acts or omission of any of the officers, employees, or agents of the University of Wisconsin System while acting within the scope of their employment, where protection is afforded by ss. 893.82 and 895.46(1), Wis. Stats.

This Agreement shall in the first instance be valid and binding for a term of three years, and may be extended by the parties' mutual, written consent. Either party may withdraw from this agreement with six months written notice to the other party.

This Agreement will become valid upon the date it is signed by the appropriate officials of the two institutions.


